Cllr Burch –

Gave an update from the Victory Hall committee meeting. This included the news that Richard Weeks had resigned from the committee.

Cllr Knowles –

Raised concern about the new tree in the square.

Raised concern about shrubs coming through the wrong side of the railings.

Cllr Barker -

Requested a thank you letter be sent to R Weeks.

Cllr Barker is having a meeting with a man about the proposed new street light on station level. He also advised that the cost of connecting the street light will be £970.

Advised that he is in the process of a street light inventory.

Following a meeting with CGP trust he advised that money from CGP trust is available tidy up the Foxfield Road entrance into Broughton.

Raised concern about the closure of section of the A595 for several weeks.

It was agreed that the clerk write a letter regarding this.

Cllr Barker does not agree with the LAP meetings.

Cllr Longworth –

Raised concern over hanging trees..

Advised that she was unable to go to the police meeting this month.

Advised that she had been invited to a meeting with the forestry commission.

Raised concern that Bracken had only had one cut.

Cllr Curwen -

Supported Cllr Barker's comments regarding the closure of part of the A595. Raising concern about emergency vehicles getting through.

Gave an update on the LAP meetings and advised that he would receive £2000 to be split between Broughton and Kirkby.

Requested a letter be sent to LAP requesting the meetings still be rotated and not held in conjunction all the time.

Advised he will having a meeting with LDNPA before the next SLDC meeting and if anyone has any issues to contact him.
Gave an update from the Duddon Estuary Partnership meeting.

Cllr Cuwen also requested any one with flooding issues to contact him as he will be attending a meeting in Kendal.
Suggested updates on charities including the Barker Grave fund.

Cllr Glessal –
Raised concern about shrubs growing on the wrong side of railings.

Cllr Kirkbride –
Raised concern on the state of roads from Greenbank and surrounding areas. Whilst some hedges have been cut, there is still cutting back which needs to be done.
