Minutes of the meeting held on Thursday 27 September 2018 in the Rankin Room Victory Hall, Broughton-in-Furness

- 166/18 Apologies**
Resolved to accept apologies from Cllr A Downe and Cllr I Longworth
- 167/18 Requests for Dispensations**
Resolved to note that there were no requests for dispensations.
- 168/18 Declaration of Interests**
Resolved to note that there were no declaration of interests.
- 169/18 To consider if there are any items on the agenda from which the press and public should be excluded.**
Resolved that no items are to be discussed in private.
- 170/18 Minutes**
Resolved that the minutes of the meeting held on Thursday 26 July 2018 be signed by the chair as a true record.
- 171/18 Chairs Announcements**
Asked the Parish Cllrs to note the timings on the agenda and advised that we will be sticking to them timings in order that the meeting finishes on time.
- 172/18 Public Participation.**
- a) Police – The police were not in attendance
 - b) The County Cllr was in attendance. He reported that an application for funding for a speed gun has been changed so that a SID can be purchased instead of the speed gun. Foxfield Road is not up to standard and a solution is being sought for the Japanese Knotweed. Weeds still have not been cut back. CCC will not do anything about the damaged green railings green railings at Wreaks End because they claim they are privately owned, however, Cllr Albion disputed this and advised that they do belong to CCC. Duddon Bridge is on the list for Structure repairs. Money has been set aside for pot holes, but he is unsure if this has all been spent.
 - c) Cllr Coward sends her apologies.
 - d) A member of the public was in attendance and once again raised concern about a cattle grid which had been replaced but was not fit for purpose. CCC say that the grid meets certain specification, but the local residents say that that particular specification is not suitable for Herdwick Sheep. The NFU are looking into whether there is a legal case.
Another member of the public was in attendance and asked the Parish Council to consider joining the R6 Group for the Kirkby Moor Wind Farm appeal. He also raised concern that the Do not follow Sat Nav signs have still not appeared at Woodland. There has been another incident with a wagon which had to reverse and did a significant amount of damage whilst doing so.

a) There was a discussion regarding exploring the case for an extension to the boundary.
b) Cllr Sayers, Cllr Pitts, Cllr Albion and Cllr Curwen were nominated to represent the Parish Council on the Southern Border Partnership.

- 178/18 Community Led Plan**
The Community Led Plan had a meeting with the Parish Council Parish, County Cllr Matt Brereton and representatives from Cumbria Highways. Highways are going to draw up and cost of a 20mph scheme for the town. This will include additional traffic calming measures for Keppleway by the school and Foxfield Road. It is anticipated that the plan will be presented to the community in early 2019. The costs of implementing the scheme will need to be met by funding applications and community fundraising.
The CLP Group have are raising funds for a speed indicator device for Church Street.
The speedwatch group are planning to start up again soon.
The Parish Handbook has been distributed to every household in Broughton.
The group are also supporting and working with the Methodist Hall to keep it viable.
- 179/18 Progress Reports from the Clerk**
a) **Public toilets** – There is concern about an invoice for the water which is over £900. This matter is being investigated..
b) **PSPO** – Still waiting for a decision from SLDC.
c) **NCCZ in Church Street** – The local PSPO Paul Harris is back at work and will get the paperwork from the Information Centre and send it off to Trading Standards in order to get the signs and posters for this.
d) **Electric Charging Points** – There is an issue with the connection to the router which is currently being worked on to resolve.
e) **Land at Foxfield** – Waiting for SLDC to advise on the wording of the restrictions.
f) **The Square** – Still waiting for the funding to come through.
g) **No Sat Nav Signs**- Still waiting for the design and costs of the signs from CCC.
h) **Wilson Park** – Survey still out yet as still waiting to hear if we have the PSPO for the park.
